



EU Global Facility on AML/CFT, Siracusa Institute partner to strengthen international judicial cooperation

**BRUSSELS/SIRACUSA, 13 September 2021 -** The EU Global Facility on Anti-Money Laundering and Counter-Terrorist Financing (EU GF-AML/CFT) and the Siracusa International Institute for Criminal Justice and Human Rights are pleased to announce their new partnership, which seeks to strengthen international judicial cooperation between judges and prosecutors.

The collaboration will consist of a number of joint activities aimed at reinforcing judges and prosecutors' capacities and specialised knowledge on AML/CF

T matters. International co-operation and co-ordination amongst the prosecution services, court staff and judges are intrinsic to fighting international organised crime, money laundering and terrorist financing in an efficient manner, the agreement between the two parties stated.
